(per Naval Historical Center)

Established 15 Feb 1943 at NAS Deland, Florida as VB-128 / VB-128, was redesignated as VPB-128 on 1 Oct 1944; VPB-128 was redesignated VP-128 on 15 May 1946; VP-128 was redesignated VP-ML-1 on 15 Nov 1946; VP-ML-1 was redesignated VP-1 on 1 Sep 1948.

VP-1 POPS HISTORY

The VP-1 P-3 Orion Pioneers (POPS) consists of people who were a part of Patrol Squadron ONE between the beginning of 1969 to the end of 1974. VP-1 transitioned to the P-3B Orion at NAS Whidbey Island in 1969 hence the name "VP-1 P-3 Orion Pioneers", commonly referred to as "VP-1 POPS". The purpose of the VP-1 POPS organization is to maintain contact amongst people who served with the squadron during those times and to facilitate periodic reunions of squadron mates from that era.

The faint beginnings of the VP-1 POPS group arose during the summer of 1996.

home in Bellingham, WA. They and the Hunts knew that there were many guys residing in the Pacific Northwest area that had been with VP-1 during the 1969 transition to P-3s, and the ensuing early Orion years. After extensive research and many phone calls a bunch of the old crew was gathered together for a Saturday cookout at *Hunt Acres* just outside Bellingham, WA.

At this gathering it was decided to expand the search for VP-1 squadronmates of the 1969 through 1974 era for a bigger get-together the following summer. By the time of the July 1997 reunion at Bellingham over 350 ex-squadronmates (officer and enlisted) had been located. Carolyn Morasch, "Shark's" wife, located a large portion of these ex-squadronmates by searching on the internet, and utilizing e-mail and the telephone for personal contact. Over 100 people attended the summer '97 reunion at Hunt's Acres. People came from all over the country. Three of our CO's from those by-gone days attended: 'Tex' Coleman; Bill Johnson; and Russ Fredrick. "Goose" Gesling's widow, Pat, also was there. (Ex-CO's Burt Howard and Cliff Freund sent regards, but were unable to attend). 1974 XO Jim Luper, was located a short time later and promptly joined the organization.

All the wise heads at that '97 reunion concurred that we should hold future reunions periodically; at the time every three years sounded right

to all concerned. So, planning for a year 2000 reunion was commenced. The VP-1 POPS group was officially organized in late 1997 after that very successful initial reunion. The first membership dues were collected, which paid for years 1998 and 1999. The second great VP-1 POPS ALL-HANDS gathering was held at Pensacola in May of 2000. Over 150 people attended this Y2K Reunion which was a resounding success. All living VP-1 CO's of the 1969-74 era except one attended this gala. A fine time was had by all, along the shores of Pensacola Bay. Retired AMSC "Willie" Williams, a resident of Pensacola, hosted this reunion. He did a great job!

At the Pensacola gathering it was decided that our next reunion would be held in the late summer of 2003 at Memphis. AMCS Mike "Grumpy" Taylor volunteered for, and was appointed as chairman for this next get-together. The Memphis Muster was held at the Naval Support Activity, Mid-South, in September of 2003. NSA Mid-South is the old NATTC Memphis located at Millington, TN, about 20 miles north of downtown Memphis. This time 180+ from the VP-1 family mustered-up. Four of the squadron's previous Commanding Officers and five of its previous Master Chiefs were there, and not a cane among them. Lots of smiles, hugs, and even some tears were seen. Mike Taylor and his group of VP-1 POPs volunteers were accorded a hearty round of applause for an outstanding job.

At the 2003 business meeting that closed-out the Memphis Muster, the assembled membership voted to hold VP-1 POPs reunions every two years vice three years. And folks chose to have their next VP-1 POPs reunion at Brunswick, ME. Greg Pierce and Quen Henderson volunteered to co-host this Maine Event during the summer of 2005. So, until further notice VP-1 POPS reunions will be held each odd numbered year. Also, a slate of officers was presented to

and approved by the membership: Bill Johnson as President, Louis Tafoya as Vice President, Greg Pierce as Secretary and Quentin Henderson as Treasurer. The President appointed Paul "Shark" Morasch as Newsletter Editor and Ed McLaughlin as Chaplain. K. B. Sherman was subsequently appointed as Membership Chairman and Internet Information Coordinator/Webmaster.

MEMBERSHIP

The VP-1 P-3 Orion Pioneers consists of people who were a part of Patrol Squadron ONE between the beginning of 1969 to the end of 1974. Persons who were attached to the squadron anytime during that period are eligible for membership including widows, ex-spouses, and tech reps. Membership keeps one on the active mailing list. Paid up members of the group receive the VP-1 POPS newsletters.

VP-1 POPS members reside in every part of our vast nation. All living CO's and XO's of the specified time frame are members. We currently have over 500 names and addresses on our VP-1 POPS roster. Sadly, over 70 of the men listed on the roster are deceased, and the number is ever increasing. There are still over 400 VP-1 squadron mates from the 1969 – 1974 era that have yet to be found. If you know the location of someone that was a part of VP-1 during 1969 – 1974 please notify the Membership Chairman or one of the officers.

Collection of a membership fee was begun in early 1998 when the group was formally organized. Many squadron mates also donated money to the organization, over and above their required membership fee, to get the organization started on a solid financial footing. Our association funds are used for publishing and distributing periodic newsletters, payment of routine office and administrative expenses, and to defray costs incurred searching for our many, as yet, unfound squadron

mates. All our association officers and committee persons serve voluntarily. No one is paid for their efforts or time.

HOW TO JOIN

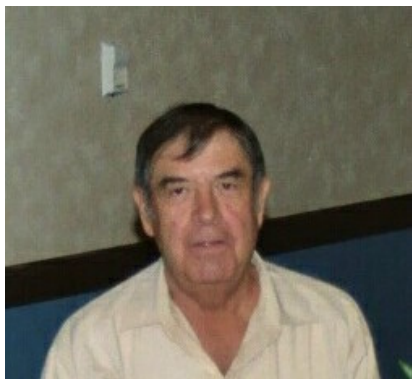
To join the VP-1 POPS, contact the Membership Chairman, the Secretary or the Treasurer. Upon your joining you will be sent a copy of the master roster containing the names, addresses, phone numbers, and e-mail addresses of all your squadron mates from the 1969 – 1974 era that have been located. This roster also indicates those that are VP-1 POPS members in-in-good-standing, and the names of squadron mates known to have passed away. On the active mailing list you will be sent future newsletters and any other pertinent information concerning the group. Current membership dues are \$15.00 for a two year cycle. Biennial VP-1 POPS dues are assessed at the beginning of each even numbered year. Dues payments are now being accepted by the VP-1 POPS Treasurer for the 2004 – 2005 biennium.

Subject: COLA

This week, the Bureau of Labor Statistics announced the monthly Consumer Price Index (CPI), which is the metric used to calculate the annual cost-of-living adjustment (COLA) for military retired pay, VA disability compensation, survivor annuities, and Social Security.

After a decline in the CPI during the last few months of 2003, inflation has rebounded as the year has progressed. The June CPI is 0.3 percent above the May tally, and 2.8 percent above last year's COLA baseline. If the June inflation rate continues for the next three months, we can expect the 2005 COLA to be in the neighborhood of 3.4 percent.

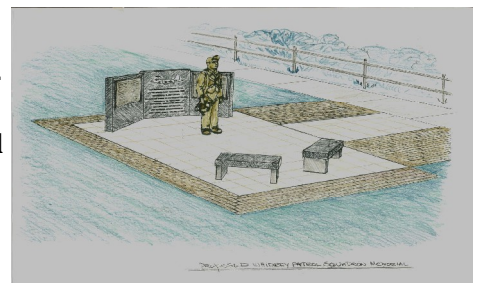

WHIDBEY PATROL SQUADRON MEMORIAL

Note: Some of the following details are OBE, but they are included to give you all a flavor of all that has transpired thus far. The next Newsletter will provide an update - Lou Tafoya.



The focal point of the memorial is a life-sized bronze statue of a VP crew-member representing all Whidbey airmen. Our "Lone Airman" is attired in flight suit, Mae West, and parachute harness and wearing a ball cap. He's holding a flight helmet in his right hand. The statue stands on a brick patio. A few feet behind the airman, and at the edge of the patio, is a three-paneled granite wall, four feet high and eight feet wide.

On the center panel above the etched words of dedication is an etched depiction of a P2V-7 Neptune. On the two granite panels on either side of the main panel will be placed the names of 85 servicemen who lost their lives in Whidbey P2V operations. The names will be cast on two bronze plaques that will be permanently attached to the outer granite walls.

Two attractive granite benches matching the granite of the memorial walls are located in front of our Lone Airman. Donation bricks surround the patio floor and the walkway leading in from the city sidewalk. This sidewalk runs from downtown Oak Harbor to the yacht club and on to the Seaplane Base. The bricks will be etched with names or dedications generated by donors who purchase the bricks.

We've had two major setbacks in our efforts to get a memorial erected on Whidbey. First, we wanted to get a real P2V as a "gate guard" at the Ault Field main gate as our memorial. But after the 9-11 attack, security regulations at NAS tightened in accordance with the new Homeland Security Regulations. The Navy no longer welcomed our Neptune aboard Ault Field (NAS Whidbey Island). That, coupled with strong guidance from our membership during the 2002 reunion to seek something other than a real aircraft, we switched to a more traditional type memorial to be located off base.

Secondly, we've had to modify our design for the memorial. The original design had two more statues; a woman and a child. We had an esti-

mate of \$150,000 for completion of this project. To get some feel for success before "going public", we asked for pledges from our VP-2 people. We received pledges for \$55,000. As a result, we reduced the funding required to \$105,000 by eliminating the statue of the woman and child. These statues can be added to the memorial at a later date if and when funding becomes available.

We are currently working with the Oak Harbor Parks Board and City Council for favorable endorsement for erecting our memorial in the small Veterans Memorial Park, (the old Catalina Park), between downtown Oak Harbor and the Seaplane Base main gate. We've made our proposal, and we keep our plan on their mind by attending city council and parks board meetings and interacting with their people. We have recently learned that Paul Brewer, a retired Navy Master Chief and friend of our project, and member of the City Council, has been assigned as the city council liaison to the Parks Board. The bureaucratic process is not fast, but our odds are increasing. We have decided that we must get an acceptable site for the memorial in order to go forward. There are many little parks scattered throughout the Oak Harbor area, but basically none that are as acceptable or that catch one's eye like the Veterans Memorial Park. So, where are we today? Pledge money is coming in, and we take every opportunity to make our project known to the city powers-that-be. At a mid-July meeting with city officials, we received the list of elements that we must present to the Parks Board. We will officially present our plan to place our memorial in the Veterans Park to the Parks Board at their August meeting. We are cautiously optimistic that they will forward a favorable recommendation to the City Council. With Council approval, we can go ahead with our plans, and "go public", so-liciting funding and support from

other squadron groups, industry, local businesses, veterans and civic groups, and individuals.

BACKGROUND

The Whidbey Patrol Squadron Memorial in the future will honor all patrol squadron personnel, officer and enlisted, aircrew and ground-pounder, of any Navy patrol squadron. It will specifically honor members of VP squadrons that were based at Whidbey anytime between the bases inception in 1942 (PBY's) and the present. VP-1 is one of those squadrons, having been based at NAS Whidbey from 1948 to 1970, and again from 1993 to the present. Currently based at Whidbey are: VP-1; VP-40; VP-46; and VP-69. VQ-1, with their EP-3's, is also here.

The P2V Neptune is representative of the VP community, as it operated from NAS Whidbey for about 25 years (1948 to the mid-1970s). VP-69 was the last P2V squadron at Whidbey to transition to P-3s -- in the mid-1970s.

There is already a P-3 Orion static display aircraft located in the center of NAS Whidbey's Ault Field. There is no P2V Neptune here, though.

This memorial project was initiated by the VP-2 Association, (ex-VP-2 people now mostly in their 60's, 70's, and 80's), but is all-inclusive for all VP people.

"(Don Hanson)-At the onset of looking for a P2, we should have formed an "Association" of all VP people. But to keep it the simplest, we (probably I) decided to keep everything to VP-2...planning to spread out to everybody when we hit a \$ milestone (for confidence) and an acceptable site. It is a Whidbey Patrol Squadron Memorial. As soon as we get the site approved, our fundraiser, Al Hall (needs help), says that we can get the rest of the \$110K...(an early and probably now low estimate.) from the other sources.... including VP-1 POPs."

Early on our memorial commit-

tee decided to make a pitch for funds to the VP-2 Association only, in order to see if there was enough support for the project. We decided not to solicit funds from outside of the VP-2 Association until we knew that the project was viable money-wise, and that we had approval to place the memorial in the Oak Harbor Veterans Park. We are now closing-in on both of those fronts -- keep you fingers crossed.

Hi Mac
I sent a message to a number of friends and family about Jeff, but several have said they didn't receive it, so I am checking with you to see if you received it. Jeff passed away Saturday morning -18 September- about 1:45 a.m. by my watch, but it took the nurse longer to check him out. He had been in the hospital for 2 weeks, and then he went back to the nursing home. I sat with

him almost around the clock in the hospital, and then every other day at the nursing home until Friday when the Dr. called me Friday morning and was crying and told me he wasn't going to make it this time. I stayed all day Friday and all night and he passed at about 1:45 a.m. (the 18th) I saw him draw his last breath and told the nurse he was gone. She said no, he was just breathing shallow, but got her stethoscope, and was surprised that I was right just by looking at him.

His Doctor told me that he was taught in medical school to not get attached to his patients, but he just couldn't help it with Jeff. He never complained about pain until about 2 weeks ago and was always so kind and considerate.

We are planning to have a memorial service at the Clyde Cosper Texas State Veteran's Home, but I haven't heard from the Chaplain yet on the time or day.

I am waiting to put the obituary in the paper until I have all the information. It will be in the paper here in Paris, and in the Fresno Bee, so that his old friends will know about it. He wanted to be cremated and taken back to Bakersfield, Calif. to be buried on top of his wife, and I intend to see that it is done. I think my surviving son and I are going to take him out there personally. He would have done that for me. The last conversation that I was able to have with him, he was worried about ME instead of himself. He was such an amazing man.

One day in 1970 I was conducting a P-3 training flight out of Cam Ranh Bay. We had junior Flight Engineer, ADR2 Connor, in the middle seat and salty old veteran Chief, ADJC McGough, as a Flight Engineer giving instructions from behind the middle seat.

The Chief and I had it worked out that the Chief would turn off the fuel to the #3 engine and call out "Flame-out #4!" The purpose of this little scheme was to teach the junior engineer to look before he leaped. The proper response would have been to scan the engine gauges, observe that it was really #3 that was flamed-out, and then pull the #3 emergency handle to feather the engine.

On my cue, the old Chief turned off #3 and called out "Flame-out #4!"

Well, the junior Flight Engineer did not look, he just reacted. Before anyone could even react, the junior engineer had the #4 emergency handle pulled out to the stop and #4, just as it should, feathered. Luckily, the weather was perfectly clear and we had a light training load of fuel. All I had to do was add a little power to #2, crank in some rudder trim, and have #3 feathered. From there we went through the shutdown checklist twice and the airborne start checklist twice and we were

back to normal business. An uneventful landing followed.
